Electronic Systems

Ride by Wire electronic throttle with 4 Riding Modes, 6-axis IMU, cruise control and a 5" TFT colour display combine to offer an experience that takes riding pleasure and safety to the next level, interpreting the rider's needs according to the riding mode selected. Other comfort-related features include the adjustable windshield which can be activated by buttons on the handlebar, reducing air pressure on the rider by up to 22%.

The LED illumination includes indicators, the taillight and a final touch in the form of Eagle DRLs, that gives an unmistakable Moto Guzzi flourish.

The 1042-cc liquid-cooled engine is compact and lightweight, blending Moto Guzzi's heritage with high performance and refined technical solutions. Compliant with Euro 5+ standards, it benefits from transmission improvements that make gear changes smoother and softer.
